Professional Summary

Frederick K. Taylor is a Co-Leader of Procopio's Privacy and Cybersecurity practice group. Fred represents clients in a wide variety of industries including high technology, Internet and electronic commerce, financial institutions, chemical companies, public entities and Native American tribes. Fred's practice focuses on litigation in the areas of intellectual property, financial institutions, complex commercial disputes, environment enforcement defense and Native American issues. He has served as First Chair in multiple jury trials, bench trials, arbitrations, mediations and appellate matters. Fred is licensed to practice in all California Courts, the Ninth, Eleventh and Federal Circuit Courts of Appeal, and multiple Federal District Courts including Texas, Florida and Illinois.

Representative Matters

- 2012-2018, represented major telecommunications company in defense of government investigation allegation of improper management of consumer protected/private information and hazardous and universal waste.
- January 2012, obtained \$1.2M settlement for Federal banking regulator from former officers and directors of failed bank.

- July 2013, obtained patent infringement verdict and judgment of \$5.85M, plus 10% royalty on behalf of manufacturer of polymer fibers, against importer and distributor of infringing products. After a two week jury trial in the Northern District of Texas, the jury returned a verdict finding the patents infringed and valid and rejecting defendants' claims of unenforceability.
- May and August 2011, obtained \$1.73M in jury verdicts in two separate trials for small business owners who were exposed to pathogens in recycled water after defendants misconnected an irrigation line to potable water line.
- October 2009, represented floor cleaning equipment manufacturer in defense of two week patent jury trial in Southern District of California. Patent claims currently rejected by USPTO following reexamination.
- October 2008, obtained substantial confidential settlement on behalf of patent owner for its technology related to parking lot security.
- July 2010, obtained a ruling from Federal Court of Appeal affirming summary judgment dismissing trademark claims against our client. The court affirmed our client's use of its registered trademark and dismissed plaintiff's cancellation and infringement claims.
- 2004-2006, obtained multiple judgments of infringement against retailers who were violating the trademarks of major flower distribution network.
- 2005, represented commercial vacuum manufacturer accused of patent infringement. Obtained evidence of invalidating prior sale of patented article, resulting in successful counterclaim of patent misuse. Client obtained attorneys' fees and dismissal of patent suit in settlement.
- 2004, represented major athletic shoe manufacturer in obtaining seizure order and temporary restraining order concerning knock-off tennis shoes that were in violation of client's trademark and trade dress rights.
- 2004, represented software development company in action against the Federal Trade Commission regarding claims unfair and deceptive practices; defeated FTC's motion for preliminary injunction and obtained favorable settlement with no payment of fine.
